Dear Vendor:

Our 2017 St. Peter School Fishermen's Festival is scheduled for the weekend of October 20, 21 and 22, 2017. We are in the process of scheduling events, entertainment and vendors for this weekend.

St. Peter Fishermen's Festival entertains hundreds of visitors each year with food, attractions, live music and entertainment. Booths are available for the sale/display/demonstration of arts and crafts and certain other merchandise and services. We would like to invite you to join us in our crafting area this year. We are excited to offer you the opportunity to rent booth space either for one day or the entire weekend.

Rental Fees: 1 day - \$40 2 days - \$75 Weekend (3 days) - \$100
(If you need electricity to your booth, it can provided at an extra cost)

Rental spaces are 10' wide x 9' deep. The spaces are located under an outside covered breezeway area. Vendors must supply their own tables. Security is provided for the duration of the festival.

The sale of anything that could be considered a weapon, or mistaken as a weapon, such as lasers, knives, toy guns, etc. is strictly prohibited. We also prohibit the sale of any items that may be considered in violation of our school policy and the teachings of the Catholic Church (i.e., obscene pictures or sayings, drug related items, etc.). Our Festival Committee, Principal and Pastor reserve the right to make a final decision on the appropriateness of an item. The sale, use, or a prize of silly string on festival grounds is prohibited. The sale of such items is in violation of your contract. If you are found selling any such items, your booth will be closed and you will need to remove your entire setup from the festival grounds, with no refund of the rental fee. St Peter School cannot restrict vendors from selling duplicate items. Vendors must comply with all requirements imposed on festival visitors.

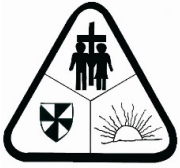
Booth spaces are limited and are rented on a first-come/first-serve basis. Your designated area will be marked upon your arrival to setup on Friday. Each rental is subject to the approval of the committee. To apply for the space, please state your intention by filling out and returning attached booth rental application and the Hold Harmless Agreement along with your check or money order made payable to St. Peter School Fishermen's Festival, 188 West 7th Street, Reserve, Louisiana 70084.

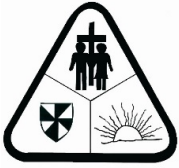

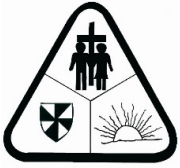

TYPE OF BOOTH (brief description of items to be sold)

Your rental payment reserves your space & constitutes your acceptance of our regulations. If the event is cancelled or postponed, rental fees are fully refundable. If a vendor cancels after acceptance of its application by the Festival committee a 20% fee will be charged and the balance of the rental fee refunded to vendor. If a vendor cancels after October 10, 2017 no refunds will be issued. Vendors must comply with all requirements.

The following are the list of requirements: Booth set-up will only be allowed during the specified time: no earlier than 3:30 p.m. on Friday, Oct. 20, 2017. Booth space, merchandise, and display racks must be removed from St. Peter School grounds no later than 2 hours after close of the Festival on Sunday, October 22, 2017. If more than 2 hours is needed to dismantle & remove items, than the booth must close earlier to allow adequate removal time. All Booths must be cleared by 8:00 p.m. on Sunday. All sales must be completed by 5:00 p.m. on Sunday. **No Loitering** is allowed- anyone assisting a vendor must stay in the craft booth area only (before and after) Festival hours. No outside food or drinks are allowed on the Festival grounds. Anyone assisting the vendor in any way must follow all rules/agreements signed by the vendor. If for any reason a negatively impacting situation was to occur involving a vendor or the vendors assistances, that vendor will be required to leave the Festival grounds with their merchandise and display without any refund of fees paid.
